Food trucks that would like to vend at Cherry Street Local Farmers Market must be in current compliance with The City of Troy. Please visit www.troyohio.gov website under Vendors License. You must hold a Mobile Food License issued by Miami County Public Health or similar and approved by MCPH. Please provide copies of these documents with your CSL application.

PLEASE PROVIDE A COMPLETE AND LEGIBLE LIST OF PRODUCTS OR MENU TO BE SOLD AT THE MARKET AND RETURN IT WITH YOUR COMPLETED APPLICATION. YOUR APPLICATION WILL NOT BE PROCESSED WITHOUT THIS LIST. Please use a separate page if needed. Please note when planning your menu, we are 9am – noon market. We will use your menu to advertise your trucks participation.

FEES

The fee is a non-refundable \$25.00 per date deposit TO RESERVE a space for your food truck. Additional fee is 10% of your total gross sales, if above \$250, while selling at Cherry Street Local on each of your designated days. This additional 10% is due on the day of service at the end of the market. We operate under the assumption that you are honest and will report your income truthfully. If we find that you are being untruthful you may not be asked to participate in the future.

A reserved spot will be allotted. Food Trucks will be stationed on S. Cherry St at the corner of Main St and S. Cherry St. on the East side of the street **OR** within the parking lot adjacent to S. Cherry St. These spaces are where electricity is available. We have an additional non-electric space at the South end of Cherry Street. Circle the weeks below you would like to participate. Currently, we only have space for one food truck per day. Please choose up to three days of participation. Dates with a line through are booked.

INSURANCE REQUIREMENTS

Provide your own \$1,000,000.00 Limited Liability Insurance.

This policy certificate **MUST** show coverage dates of the Market indicated as June 2025 through September 2025.

This policy certificate **MUST** list the two Additional Insureds that follow, both A and B.

- A. The Miami County Local Food Council.
- B. The City of Troy. The City of Troy’s listing must include the provided verbiage below in italics.

Provided verbiage for the City of Troy listing as additional insured, this must be on your provided proof of insurance **exactly as written**. *The City of Troy, Ohio, its elected and appointed officials, all employees, agents, volunteers, all boards, commissions and/or authorities and board members, including employees, agents, and volunteers thereof. Coverage shall be primary to the Additional Insureds and not contributing with any other insurance or similar protection available to the Additional Insureds whether other available coverage be primary, contributing, or excess.*

- Copies of applicable health permit/licenses
- Check for fees
- Signed Application
- Property & Product Liability Insurance
